AGREEMENT:

- You will be set up outside and you need to be prepared for any weather. For safety reasons, you must tie down your booth and provide your own leveling.
- You are responsible for collecting and paying NY State sales tax (currently 7.5%).
- No drinking alcohol or smoking will be allowed in the vendor booths.
- No pets are allowed, with the exception of guide or service dogs. If you do bring your pet, you will be asked to remove them.
- It is understood that your area shall be cleaned after close of business and during business hours as required.
- Phelps Volunteer Fire Dept reserves the right to terminate this contract at any time if these policies are not adhered to.
- Agreements will be honored on a first come first serve basis.
- Phelps Volunteer Fire Dept will not be held responsible for damage to vendor's materials or property due to theft, adverse weather conditions or improper set-ups.
